2. Administrative update from Provost:

 - a. Who our students are:
 - i. Many want help selecting an academic program, jobs are the ultimate goal of many students, many report a high desire to transfer before they even go to their first class
 - ii. Retention priorities
 - iii. Importance of advising appointments
 - b. Progress reports: important—49% who receive notice of concern end up earning an A, B, or C
 - c. SAS overview:
 - i. 3 categories of services:
 1. Career Strategy
 2. Student Support Programs
 3. Academic supports "class"

 1. Retention & graduation

 - d. How SAS supports faculty
 - i. Supplemental instructions & tutoring—open to all classes, focus on high DFWs
 - ii. Classroom visits—awareness & skill-building opportunities workshop
 - iii. Progress report/data analysis
 - iv. Career and major exploration
 - e. Faculty supporting SAS:
 - i. Examining solutions to common barriers
 - ii. Address research questions
 - iii. Faculty recommendations for tutors, etc.
 - iv. Co-curricular opportunities for students
 - f. Q&A:
 - i. How student affairs and student academic success relate
 - 1. Student Academic Success: retention, co-curricular programs, transition programs, etc.—>ensure students' they are here success while here
 - 2. Student Affairs: residence life, wellness center, new Title IX office, VPVA, Dean of Students, disability services (reports to Wellness center now), student involvement—>focused on student engagement, wellness, housing, student code of conduct
 - ii. Internships/Career Services
4. Discussion about online courses/teaching—when courses should be offered online vs. in-person
- a. Involves many broad issues, including school- and program-specific considerations, market issues that need to be navigated together with Admissions, and strategic planning
 - b. Importance of defining what face-to-face, hybrid, and online mean
 - c. Importance of communication about curricular changes
